SISSETON-WAHPETON SIOUX BUSINESS CORPORATION ORDINANCE

- 08-01-01 SHORT TITLE This Ordinance shall be known and may be cited as the Sisseton-Wahpeton Sioux Business Corporation Ordinance.
- 08-02-01 DEFINITIONS As used in this Ordinance, the following terms shall have the following respective meanings.
- Corporation or Domestic Corporation means a corporation 08-02-02 for profit subject to the incorporation or articles of consolidations and all amendments thereto including articles of merger.
- Articles of Incorporation means the original or reinstated 08-02-03 articles of incorporation or articles of consolidations and all amendments thereto including articles of merger.
- Shares means the units into which the proprietary 08-02-04 interests in a corporation are divided.
- Subscriber means one who subscribes for shares in a corporation, whether before or after incorporation.
- Shareholder means one who is a holder of record of shares 08-02-06 in a corporation.
- 08-02-07 Authorized Shares means the shares of all classes which the corporation is authorized to issue.
- Net Assets means the amount by which the total assets of a corporation is authorized to issue.
- Stated Capital means, at any particular time, the sum of: 08-02-09
 - The par value of all shares that have been issued; and 1.
 - Such amounts not included in clause 1. of this 2. paragraph as have been transferred to stated capital of the corporation, whether upon the issue of shares as a share dividend or otherwise, minus all reductions from such sums as have been affected in a manner permitted by law.
- 08-02-10 Surplus means the excess of the net assets of a corporation over its stated capital.

- O8-02-11 Earned Surplus means the portions of the surplus of a corporation equal to the balance of its net profits, income, gains and losses from the date of incorporation, or from the latest date when a deficit was eliminated by an application of its capital surplus or stated capital or otherwise, after deducting subsequent distributions to shareholders and transfer to stated capital and capital surplus to the extent such distribution and transfers are made out of earned surplus.
- 08-02-12 <u>Capital Surplus</u> means the entire surplus of a corporation other than its earned surplus.
- 08-02-13 <u>Insolvent</u> means inability of a corporation to pay its debts as they become due in the usual course of its business.
- 08-02-14 <u>Employee</u> includes officers, but not directors. A director may accept duties which make him also an employee.
- 08-02-15 Tribal Treasurer means the Treasurer of the Sisseton-Wahpeton Sioux Tribe.
- O8-03-01 PURPOSES

 Corporations may be organized under this Ordinance for any lawful purpose or purposes, except for the purpose of banking or insurance.

- 08-04-01 GENERAL POWERS

 Each corporation shall have the power:
 - To have perpetual succession by its corporate name unless a limited period of duration is stated in its articles of incorporation;
 - 2. To sue and be sued, complain and defend, in its corporate name;
 - 3. To have a corporate seal which may be altered at pleasure, and use the name by causing it, or a facsimile thereof, to be impressed or affixed or in any other manner reproduced;
 - 4. To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated;
 - 5. To sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets;
 - To lend money and use its credit to assist its employees;
 - 7. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, obligations of corporations (whether or not

incorporated under the Ordinance), associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district or municipality or of any instrumentality thereof, or of any Indian tribe;

- 8. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income;
- 9. To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested;
- 10. To conduct its business, carry on its operations and have offices and exercise the powers granted by this Ordinance within or without this Reservation;
- 11. To elect, to appoint officers, and agents of the corporation, and define their duties and fix their compensation;
- 12. To make and alter by-laws not consistent with its Article or Incorporation or with this Ordinance or any other law, ordinance or regulations of the Sisseton-Wahpeton Sioux Tribe, for the administration and regulation of the affairs of the Corporation;
- 13. To make donations for the public Welfare or for charitable, scientific, or educational purposes;
- 14. To transact any lawful business which the Board of Directors shall find will be in aid of governmental policy;
- 15. To pay pensions and establish pension plans, pension trusts, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees;
- 16. To be a promoter, partner, member, associate, or manager of any partnership, joint venture, trust or other enterprise; and
- 17. To have and exercise all powers necessary or convenient to effect its purpose.

08-05-01 DEFENSE OF ULTA VIRES

No act of a corporation and no conveyance or transfer of real or personal property to or by a corporation shall be invalid by reason of the fact that the corporation was without capacity or power to do such act or to make or receive such conveyance or transfer, but such lack of capacity or power may be asserted:

- In a proceedings by a shareholder against the 1. corporation to enjoin the doing of any act or the transfer of real or personal property by or to the If the unauthorized act or transfer corporation. sought to be enjoined is being, or is to be performed or made pursuant to a contract to which the corporation is a party, the Court may, if all of the parties to the contract are parties to the proceeding and if it deems the same to be equitable set aside and enjoin the performance of such contract, and in so doing may allow to the corporation or to the other parties to the contract, as the case may be, compensation for the loss or damage sustained by either of them which may result from the action of the Court in setting aside and enjoining the performance of such contract, but anticipated profits to be derived from the performance of the contract shall be awarded by the Court as a loss or damage sustained;
- 2. In a proceeding by the corporation, whether acting directly or through a receiver, trustee, or other legal representative, or through shareholders in a representative suit, against the incumbent or former officers or directors of the corporation; and
- 3. In a proceeding by the Tribal Treasurer, as provided in this Ordinance, to dissolve the corporation, or in a proceeding by the Tribal Treasurer to enjoin the corporation from the transaction of an authorized business.

08-06-01 CORPORATE NAME The corporate name:

- 1. Shall contain the "corporation", "company", "incorporated", or "limited", or shall contain an abbreviation of one of such words;
- Shall not contain any word or phrase which indicates or implies that it is organized for any purpose other than one or more of the purposes contained in its articles of incorporation; and
- 3. Shall not be the same as, or deceptively similar to, the name of any corporation existing under this Ordinance or any other corporation authorized to transact business on the Lake Traverse Indian Reservation.

08-07-01 REGISTERED OFFICE AND REGISTERED AGENT Each corporation shall have and continuously maintain on this Reservation:

- 1. A registered office; and
- A registered agent.

08-08-01 SERVICE OF PROCESS ON CORPORATIONS

The registered agent so appointed by a corporation upon whom any process, notice or demand required or permitted by law, to be served upon the corporation, may be served. Whenever a corporation shall fail to appoint or maintain a registered agent on this Reservation, or whenever its registered agent cannot, with reasonable diligence be found at the registered office, the Tribal Treasurer shall be an agent of such corporation upon whom any such process, notice, or demand may be served.

- O8-08-02 Service on the Tribal Treasurer of any such process, notice, or demand shall be made by delivering to and leaving with him, or with any clerk having charge of the corporation department of his office, duplicate copies of such process, notice or demand. In the event any such process, notice or demand is served on the Tribal Treasurer, he shall immediately cause one of the copies thereof to be forwarded by registered mail, addressed to the corporation at its registered office. Any service so had on the Tribal Treasurer shall be returnable in not less than thirty (30) days.
- 08-08-03 The Tribal Treasurer shall keep a record of all processes, notices, and demands served upon him under this Section, and shall record therein the time of such service and his action with reference thereto.
- 08-08-04 Nothing contained herein shall limit or affect the right to serve any process, notice or demand required or permitted by law to be served upon a corporation in any other manner now or hereafter permitted by law.
 - 08-09-01 AUTHORIZED SHARES

 Each corporation shall have power to create and issue the number of shares stated in its articles of incorporation. Such shares shall be of only one class and shall be shares with par value.
 - 08-10-01 CONSIDERATION FOR SHARES

 Shares may be issued for such consideration expressed in dollars, not less than the par value thereof, as shall be fixed from time to time by the Board of Directors.
 - O8-11-01 PAYMENT OF SHARES

 The consideration for the issuance of shares may be paid, in whole or in part, in money, in other property, tangible or intangible, or in labor or services actually performed for the corporation; such shares shall be deemed to be fully paid and non-assessable.
 - 08-11-02 Neither promissory notes or future services shall constitute payment or part-payment for the issuance of shares of a corporation.
- 8-11-03 In the absence of fraud in the transaction, the judgement of the Board of Directors or the shareholders, as the case may be, as to the value of the consideration received for shares will be conclusive.

- O8-12-01 DETERMINATION OF AMOUNT OF STATED CAPITAL

 The consideration received for shares shall constitute stated capital to the extent of the par value of such shares, and the excess, if any, of such consideration shall constitute capital surplus.
- O8-13-01 CERTIFICATE REPRESENTING SHARES

 The shares of a corporation shall be represented by certificates signed by the President or a Vice-President and the Secretary or an Assistant Secretary of the corporation, and may be sealed with the seal of the corporation or a facsimile thereof.
- 08-13-02 Each certificate representing shares shall state upon the face thereof:
 - 1. That the corporation is organized under an Ordinance of the Sisseton-Wahpeton Sioux Tribe;
 - 2. The name of the person to whom issued;
 - 3. The number of shares, which such certificate represents; and
 - 4. The par value of each share represented by such certificate.
- 08-13-03 No certificate shall be issued for any share until such share is fully paid.
- The initial By-laws of a corporation shall be adopted by its Board of Directors. The power to alter, amend, or repeal the by-laws or adopt new by-laws, subject to repeal or change by action of the shareholders, shall be vested in the Board of Directors unless reserved by the shareholders by the articles of incorporation. The by-laws may contain any

the articles of incorporation. The by-laws may contain any provisions for the regulation and management of the affairs of the corporation not inconsistent with this Ordinance or the articles of incorporation.

08-15-01 MEETINGS OF SHAREHOLDERS

BY-LAWS

08-14-01

Meetings of shareholders may be held at such place on this Reservation as may be stated in, or fixed in accordance with the by-laws. If no other place is state in or so fixed, meetings shall be held at the registered office of the corporation.

- O8-15-02 An annual meeting of shareholders shall be held at such time as may be stated in or fixed in accordance with the by-laws. If the annual meeting is not held within any thirteen (13) month period, the Sisseton-Wahpeton Sioux Tribal Court may, on the application of any shareholder, summarily order a meeting to be held.
- 08-15-03 Special meeting of the shareholders may be called by the Board of Directors, the holders of not less than one-tenth (1/10) of all the shares entitled to vote at the meeting, or such other persons as may be authorized in the articles of incorporation by the by-laws.

08-16-01 NOTICE OF SHAREHOLDER'S MEETINGS

Written notice stating the place, day, and hour of the meeting and, in case of a special meeting, shall be delivered not less than the (10) days nor more than fifty (50) days before the date of the meeting, either personally or by mail, by or at the direction of, the president, secretary, or the officer or person calling the meeting, to each shareholder of record entitled to vote at such a meeting. If mailed such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the shareholder at his address as it appears on the stock transfer books of the corporation, with postage thereon prepaid.

08-17-01 CLOSING OF TRANSFER BOOKS AND FIXING RECORD DATE

For the purpose of determining shareholders entitled to notice of or to vote at any meeting of shareholders or any adjournment thereof, or entitled to receive payment of any dividend, or in order to make a determination of shareholders for any other proper purpose, the Board of Directors of a corporation may provide that the stock transfer books shall be closed for a stated period but not to exceed, in any case, ten (10) days.

08-18-01 VOTING RECORD

The officer or agent having charge of the stock transfer books for shares of a corporation shall make a complete record of the shareholders entitled to vote at such meetings or any adjournment thereof, arranged in alphabetical order, with the address of and the number of shares held by each. Such record shall be produced and kept open at the time and place of the meeting and shall be subject to the inspection of any shareholder during the whole time of the meeting for the purposed thereof.

- 08-18-02 Failure to comply with the requirements of this Section shall not affect the validity of any action taken at such meeting.
- 08-18-03 An officer or agent having charge of the stock transfer books who shall fail to prepare the record of shareholders, or produce and keep it open for inspection at the meeting, as provided in this Section, shall be liable to any shareholder suffering damage on account of such failure, to the extent of such damage.

08-19-01 QUORUM OF SHAREHOLDERS

Unless otherwise provided in the articles of incorporation, a majority of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders, but in no event shall a quorum consist of less than one-third of the shares entitled to vote at the meeting. If a quorum is present, affirmative vote of the majority of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders, unless the vote of a greater number is required by this Ordinance or the articles of incorporation or by-laws.

08-20-01 VOTING OF SHARES

Each outstanding share shall be entitled to one vote on each matter submitted to a vote at the meeting of shareholders, except as may be otherwise provided in the articles of incorporation. If the articles of incorporation provided for more or less than one vote for any share, on any matter, every reference in this Ordinance to a majority or other proportion of votes entitled to be cast.

08-20-02 A shareholder may vote either in person or by proxy executed in writing by the shareholder or by his duly authorized attorney-in-fact. No proxy shall be valid after eleven (11) months from the date of its execution, unless otherwise provided in the proxy.

08-21-01 BOARD OF DIRECTORS

The business and affairs of a corporation shall be managed by a Board of Directors except as may be otherwise provided in the articles of incorporation. The Board of Directors shall have the authority to fix the compensation of directors unless otherwise provided in the articles of incorporation.

08-22-01 NUMBER AND ELECTION OF DIRECTORS

The Board of Directors of a corporation shall consist of one or more members. The number of directors shall be fixed by, or in the manner provided in, the articles of incorporation or the by-laws, except as to the number constituting the initial Board of Directors, which number shall fixed by the articles of incorporation. The number of directors may be increased or decreased from time to time by amendment to, or in the manner provided in the articles of incorporation or the by-laws, but no decrease shall have the effect of shortening the term of any incumbent director. The names and addresses of the members of the Board of Directors shall be stated in the articles of incorporation. Such persons shall hold office until the first annual meeting of shareholders, and until their successors shall have been elected and qualified. At the first meeting of shareholders and at each annual meeting thereafter, the shareholders shall elect directors to hold office until the next succeeding annual meeting, except in case of the classification of directors as permitted by the Ordinance. Each director shall hold office for the term for which he is elected and qualified.

08-23-01 VACANCIES

Any vacancy occurring in the Board of Directors may be filled by the affirmative vote of a majority of the remaining directors though less than a quorum of the Board of Directors. A director elected to fill a vacancy shall be elected for the unexpired term of his predecessor in office. Any directorship to be filled by reason of an increase in the number of directors may be filled by the Board of Directors for a term of office continuing only until the next election of directors by the shareholders.

08-24-01 REMOVAL OF DIRECTORS

At a meeting of shareholders called expressly for that purpose, directors may be removed in the manner provided in this Section. Any Director or the entire Board of Directors may be removed, with or without cause, by a vote of the holders of a majority of the shares then entitled to vote at an election of directors.

08-25-01 QUORUM OF DIRECTORS

A majority of the number of directors fixed by, or in the manner provided in, the by-laws, or in the absence of a by-law fixing or providing for the number of directors, of the number stated in the articles of incorporation shall constitute a quorum for the transaction of business unless a greater number is required by the articles of incorporation or the by-laws. The act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the Board of Directors, unless the act of a greater number is required by the articles of incorporation or the by-laws.

08-26-01 NO CONTRACT VOID OR VOIDABLE

No contract or other transaction between a corporation and one or more of its directors or any other corporation, firm, association or entity in which one or more of its directors are directors or officers, or are financially interested, shall be either void or voidable because of such relationship or interest or because such director or directors are a committee thereof which authorizes, approves, or ratifies such contract or transaction or because his or their votes are counted for such purpose, if:

- 1. The fact of such relationship or interest is disclosed or known to the Board of Directors or a committee thereof which authorizes, approves, or ratifies, the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of such interested directors; or
- 2. The fact of such relationship or interest is disclosed or known to the shareholders entitled to vote and they authorize, approve or ratify such contract or transaction by vote or written consent; or
- 3. The contract or transaction is fair and reasonable to the corporation. Common or interested Directors may be counted in determination of the presence of a quorum at a meeting of the Board of Directors or a committee thereof which authorizes, ratifies, or approves such contract or transaction.

08-27-01 EXECUTIVE AND OTHER COMMITTEES

If the articles of incorporation or the by-laws so provide, the Board of Directors, by resolution adopted by a majority of the full Board of Directors, may designate from among its members an executive committee and/or other committees, each of which, to the extent provided in such resolution or in the articles of incorporation or the by-laws of the corporation, shall have and may exercise all authority of the Board of Directors, but no such committee shall have the

authority of the Board of Directors in reference to amending the articles incorporation; adopting a plan for merger or consolidation; recommending to the shareholders the sale. or other disposition of exchange, substantially all the property and assets of corporation, otherwise than in the usual and regular course of its business; recommending to the shareholders the voluntary dissolution of the corporation, or a revocation thereof; or amending the by-laws of the corporation. The designation of any such committee and the delegation thereto of authority shall not operate to relieve the Board of Directors, or any member thereof, of any responsibility imposed by law.

- 08-28-01 PLACE AND NOTICE OF DIRECTOR'S MEETINGS
 Meeting of the Board of Directors, regular or special, may be held either within or without this Reservation.
- O8-28-02 Regular meetings of the Board of Directors may be held with or without notice as prescribed in the by-laws. Special meetings of the Board of Directors shall be held upon such notice as is prescribed in the by-laws. Attendance of a director at a meeting shall constitute a waiver of notice of such meeting, except where a director attends a meeting for the express purpose of objecting to the transaction of any business because the meeting is not lawfully called or convened. Neither the business to be transacted, nor the purpose of, any regular meeting of the Board of Directors need be specified in the notice or waiver of notice of such meeting unless required by the by-laws.
- O8-29-01 ACTION BY DIRECTORS WITHOUT A MEETING
 Unless otherwise provided by the articles of incorporation or by-laws, any action required by this Ordinance to be taken at a meeting of the directors of a corporation, or any action which may be taken at a meeting of the directors or of a committee, may be taken without a meeting, if a consent, in writing, setting forth the action so taken, shall be signed by all the directors, or all of the members of the committee, as the case may be. Such consent shall have the same effect as a unanimous vote.
- O8-30-01 DIVIDENDS

 The Board of Directors of a corporation may from time to time, declare; and the corporation may pay dividends in cash, property, or its own shares, except when the corporation is insolvent or when the payment thereof would render the corporation insolvent, or when the payment thereof would be contrary to any restriction contained in the articles of incorporation.
- O8-31-01 DISTRIBUTIONS FROM CAPITAL SURPLUS

 The Board of Directors of a corporation may from time to time distribute to its shareholders out of capital surplus of the corporation, a portion of its assets, in cash or property, subject to the following provisions:
 - No such distribution shall be made at the time when the corporation is insolvent or when such distribution would render the corporation insolvent;

- 2. No such distribution shall be made unless the articles of incorporation so provide or such distribution is authorized by the affirmative vote of the holders of a majority of the outstanding shares of each class whether or not entitled to vote thereon by the provisions of the articles of incorporation of the corporation;
- 3. No such distribution shall be made to the holders of any class unless all cumulative dividends accrued on all preferred or special classes or shares entitled to preferential dividends shall have been fully paid;
- 4. No such distribution shall be made to the holders of any class of shares which would reduce the remaining net assets of the corporation below the aggregate preferential amount payable in event of involuntary liquidation to the holders of shares having preferential rights to the assets of the corporation in the event of liquidation; and
- 5. Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share is disclosed to the shareholders receiving the same, concurrently with the distribution thereof. The Board of Directors of a corporation may also, from time to time, distribute to the holders of its outstanding shares having a cumulative preferential right to receive dividends, in discharge of their cumulative dividends rights, dividends payable in cash, out of the capital surplus of the corporation; if at the time the corporation has no earned surplus and is not insolvent and would not thereby be rendered insolvent. Each such distribution, when made, shall be identified as a payment of cumulative dividends out of capital surplus.
- O8-32-01 LOANS TO EMPLOYEES AND DIRECTORS

 A corporation shall not lend money to or use its credit to assist its directors without authorization in the particular case by its shareholders.
- 08-33-01 LIABILITY OF DIRECTORS IN CERTAIN CASES
 In addition to any other liabilities imposed by law upon directors of a corporation:
 - 1. Directors of a corporation who vote for an assent to the declaration of any dividend or other distribution of the assets of a corporation to its shareholders contrary to the provisions of this Ordinance, or contrary to any restrictions contained in the articles of incorporation, shall be jointly and severally liable to the corporation for the amount of such dividend which is paid or the value of such assets which are distributed in excess of the amount of such dividends or distribution, which could have been paid or distributed without a violation of this act or the restrictions in the articles of incorporation;

- Directors of a corporation who vote for or assent to the purchase of its own shares contrary to the provisions of this Ordinance shall be jointly and severally liable to the corporation for the amount of consideration paid for such shares which is in excess of the maximum amount which could have been paid therefore without a violation of the provisions of this Ordinance; and
- 3. The directors of a corporation who vote for or assent to any distribution of assets of a corporation to its shareholders during the liquidation of the corporation, without the payment and discharge of, or making adequate provisions for all known debts, obligations, and liabilities of the corporation shall be jointly and severally liable to the corporation for the value of such assets which are distributed, to the extend that such debts, obligations, and liabilities of the corporation are not thereafter paid and discharged.
- A director of a corporation who is present at a meeting of its Board of Directors at which action on any corporate matter is taken shall be presumed to have assented to the action taken unless his dissent shall be entered in the minutes of the meeting, or unless he shall file his written dissent to such action with the Secretary of the meeting before adjournment thereof or shall forward after the adjournment of the meeting. Such right to dissent shall not apply to a director who voted in favor of such action.
- 08-33-03 A director shall not be liable under Section 08-33-01, subsections 1, 2, and 3, if he relied and acted in good faith upon financial statements of the corporation represented to him to be correct by: the president of, or the officer of such corporation having charge of its books of account, or stated in a written report by an independent public or certified public accountant or firm of such accountants, which fail to reflect the financial condition of such corporation, nor shall he be so liable if, in good faith in determining the amount available for any such dividend or distribution, he considered the assets to be of their book value.
- O8-33-04 Any director against whom a claim be asserted under or pursuant to this Section for the payment of a dividend or other distribution of assets of a corporation who shall be held liable thereon, shall be entitled to contribution from the shareholders who accepted or received any such dividend or assets knowing such dividend or distribution to have been made in violation of this Ordinance in proportion to the amounts received by them.
- 08-33-05 Any director against whom a claim be asserted under or pursuant to this Section shall be entitled to contribution from the other Directors who voted for or assented to the action which claim is asserted.

08-34-01 OFFICERS

The officers or a corporation shall consist of a president, one or more vice-presidents as may be prescribed by the bylaws, a secretary, and a treasurer; each of whom shall be elected by the Board of Directors at such time and in such manner as may be prescribed by the by-laws. Such other officers and assistant officers and agents as may be deemed necessary, may be elected or appointed by the Board of Directors or chosen in such other manner as may be prescribed by the by-laws. Any two or more offices may be held by the same person, except the offices of president or secretary.

A SECTION OF THE

08-34-02 All officers and agents of the corporation, as between themselves and the corporation, shall have such authority and perform such duties in the management of the corporation as may be provided in the by-laws, or as may be determined by resolution of the Board of Directors not inconsistent with the by-laws.

08-35-01 REMOVAL OF OFFICERS

Any officer or agent may be removed by the Board of Directors whenever, in its judgement, the best interests of the corporation will be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the person so removed. Election or appointment of an officer or agent shall not, of itself, create contract rights.

8-36-01 BOOKS AND RECORDS

Each corporation shall keep correct and complete books and records of each account and shall keep minutes of the proceedings of its shareholders and Board of Directors, and shall keep at its registered office or principal place of business, or at the office of its transfer agent or registrar, a record of its shareholders, giving the names and addresses of all shareholders, and the number and class of shares held by each. Any books, records and minutes may be in written form or in any other form capable of being converted into written form within a reasonable time. person who shall have been a holder of record of shares or of voting trust certificates therefore at least six (6) months immediately preceding his demand, or shall be the holder of record of, or the holder of record of voting trust certificates for, at least five percent (5%) of all the outstanding shares of the corporation, upon written demand stating the purpose thereof, shall have the right to examine, in person, or by agent or attorney, at any reasonable time or times, for any proper purpose, its relevant books and records of account, minutes and record of shareholders and to make transactions therefrom.

O8-36-02 Any officer or agent who, or a corporation which, shall refuse to allow any such shareholder or holder of voting trust certificates, or his agent or attorney, so to examine and make extracts from its books and records of accounts, minutes, and record of shareholders, for any proper purpose, shall be liable to such shareholder or holder of voting trust certificates in a penalty of ten percent (10%) of the value of the shares owned by such shareholders, or in

respect of which such voting trust certificates are issued, in addition to any other damages or remedy afforded him by It shall be a defense to any action for penalties under this section that the person suing therefore has, within two (2) years sold or offered for sale any list of shareholders or of holders of voting trust certificates for shares of such corporation, or any other corporation or has aided or abetted any person in procuring any list of shareholders or of holders of voting trust certificates for any such purpose; or has improperly used any information secured through any prior examination of the books and records of accounts, or minutes or record of shareholders or of holders of voting trust certificate for shares of such corporation, or any other corporation; or was not acting in good faith or for a proper purpose in making his demand. Nothing contained in this section shall impair the power of any court of competent jurisdiction, upon proof by a shareholder or holder of voting trust certificates, of proper purpose, irrespective of the period of time during such shareholder or holder of voting trust certificates shall have been a shareholder of record or holder of voting trust certificates and irrespective of the number of shares held by him or represented by voting trust certificates held by him, to compel the production for examination by such shareholder or holder of voting trust certificates of the books and accounts, minutes and record of shareholders of a corporation.

If the Tribal Treasure finds that such statement conforms to law, he/she shall, when all fees and franchise taxes have been paid as in the Ordinance prescribed:

- 1. Endorse on each of such duplicate originals the "Filed", and the month, day, and year of the filing thereof;
- 2. File one of such duplicate originals in his or her office; and
 - Return the other duplicate original to the corporation or its representative.

08-61-01 EFFECT OF STATEMENT OF REVOCATION OF VOLUNTARY DISSOLUTION PROCEEDINGS

Upon the filing by the Tribal Treasurer of a statement of revocation of voluntary dissolution proceedings, whether by consent of shareholders or by act of the corporation, the revocation of the voluntary dissolution proceedings shall become effective and the corporation may again carry on its business.

08-62-01 ARTICLES OF DISSOLUTION

If voluntary dissolution proceedings have not been revoked, then when all debts, liabilities, and obligations of the corporation have been paid and discharged, or adequate provision has been made therefor, and all of the remaining property and assets of the corporation have been distributed to its shareholders, articles of dissolution shall be executed in duplicate by the corporation; by its president or a vice-president, and by its secretary or an assistant secretary, and verified by one of the officers signing such statement, which statement shall set forth:

1. The name of the corporation;

- 2. That the Tribal Treasurer theretofore filed a statement of intent to dissolve the corporation, and the date on which such statement was filed;
- 3. That all debts, obligations and liabilities of the corporation have been paid and discharged or that adequate provisions have been made therefore;
 - 4. That all remaining property and assets of the corporation have been distributed among its shareholders in accordance with their respective rights and interests; and
 - 5. That there are no suits pending against the corporation in any Court, or that adequate provisions have been made for the satisfaction of any judgement, order or decree which may be entered against it in any pending suit.

08-63-01 FILING ARTICLES OF DISSOLUTION

Duplicate originals of such articles of dissolution shall be delivered to the Tribal Treasurer. The Tribal Treasurer finds that such articles of dissolution conform to the law, he or she shall, when all fees and franchise taxes have been paid as in this Ordinance prescribed:

- 1. Endorse on each of such duplicate originals the word "Filed", and the month, day, and year of the filing thereof;
- 2. File on of such duplicate originals in his office; and
- 3. Issue a certificate of dissolution to which he/she shall affix the other duplicate original.

O8-63-02 The certificate of dissolution, together with the duplicate original of the articles of dissolution affixed thereto by the Tribal Treasurer shall be returned to the representative of the dissolved corporation. Upon the issuance of such certificate of dissolution, the existence of the corporation shall cease, except for the purpose of suits, other proceedings, appropriate corporate action by shareholders, directors and officers as provided in this Ordinance.

08-64-01 INVOLUNTARY DISSOLUTION

A corporation may be dissolved involuntarily by a decree of the Sisseton-Wahpeton Sioux Tribal Court in an action filed by the Tribal Treasurer when it is established that:

- 1. The corporation has failed to file its annual report within the time required by this Ordinance, or has failed to pay its franchise tax on or before the first day of August of the year in which such franchise tax becomes due and payable; or
- 2. The corporation procured its articles of incorporation through fraud; or
- 3. The corporation has continued to exceed or abuse the authority conferred upon it by law; or

- 4. The corporation has failed, for thirty days, to appoint and maintain a registered office or registered agent in this Reservation; or
- of such change.

08-65-01 NOTIFICATION TO THE TRIBAL TREASURER

If on or before the last day of December, a corporation shall have failed to file its annual reports or to pay franchise taxes in accordance with the provisions of this Ordinance or shall have given cause for dissolution as provided in this Ordinance, the Tribal Treasurer shall file an action in the name of the Tribe against such corporation for its dissolution.

os-65-02 If, after such action has been filed, the corporation shall file its annual report or pay its franchise tax, together with all penalties thereon, or shall appoint or maintain a registered agent as provided in this Ordinance, or shall file with the Tribal Treasurer, the required statement of change of registered office or agent, and shall pay the costs of such action, the action for such cause shall abate.

08-66-01 JURISDICTION OF COURT TO LIQUIDATE ASSETS AND BUSINESS OF CORPORATION

The Sisseton-Wahpeton Sioux Tribal Court shall have full power to liquidate the assets and business of a corporation;

- 1. In an action by a shareholder when it is established:
 - a. That the Directors are deadlocked in the management of the corporate affairs and the shareholders are unable to break the deadlock; and that irreparable injury to the corporation is being suffered or is threatened by reason thereof; or
 - b. That the acts of the Director or those in control of the corporation are illegal, oppressive, or fraudulent; or
 - c. That the shareholders are deadlocked in voting power, and have failed, for a period which includes at least two (2) consecutive annual meeting dates, to elect successors to Directors whose terms have expired or would have expired upon the election of their successors; or
 - d. That the corporate assets are being misapplied or wasted.

2. In an action by a creditor:

a. When the claim of the creditor has been reduced to judgement and an execution thereon returned unsatisfied and it is established that the corporation is insolvent.

- 3. Upon application by a corporation which has filed a statement of intent to dissolve, as provided in this Ordinance, to have its liquidation continued under the supervision of the Court; and
- 4. When an action has been filed by the Tribal Treasurer to dissolve a corporation and it is established that liquidation of its business and affairs should precede the entry of a decree of dissolution.
- 08-66-02 It shall not be necessary to make shareholders parties to any such action or proceeding unless relief is sought against them personally.
- O8-67-01 PROCEDURE IN LIQUIDATION OF CORPORATION BY COURT

 In proceedings to liquidate the assets and business of a corporation the Court shall have power to issue injunctions, to appoint a receiver or receivers pendente lite, with such powers and duties as the Court, from time to time, may direct and to take such other proceedings as may be requested to preserve the corporate assets wherever situated, and carry on business of the corporation until a full hearing can be held.
- O8-67-02 After a hearing had upon such notice as the Court may direct to be given to all parties to the proceedings and to any other parties in interest designated by the Court, the Court may appoint a liquidating receiver or receivers with authority to collect the assets of the corporation, including all amounts owing to the corporation by subscribers on account of any unpaid portion of the consideration for the issuance of shares. Such liquidating receiver shall have authority, subject to the order of the Court, to sell, convey, and dispose of all or any part of the assets of the corporation whenever situated, either at public or private sale.
- O8-67-03 The assets of the corporation or the proceeds resulting from a sale, conveyance or other disposition thereof shall be applied to the expenses of such liquidation and the payment of the liabilities and obligations of the corporation, and any remaining assets or proceeds shall be distributed among its shareholders according to their respective rights and interests. The order appointing such liquidation receiver or receivers shall state their powers and duties. Such powers and duties may be increased or diminished at any time during the proceedings.
- O8-67-04 The Court shall have the power to allow, from time to time, as expenses of the liquidation compensation to the receiver or receivers and to attorneys in the proceedings, and to direct the payment thereof out of the assets of the corporation or the proceeds of any sale or disposition of such assets.

- of this Section shall have authority to sue and defend i all Courts in his own name as receiver of such corporation. The Court appointing such receiver(s) shall have exclusive jurisdiction of the corporation and its property, wherever situated.
- 08-68-01 QUALIFICATION OF RECEIVERS

 A receiver shall in all cases be a natural person or a corporation authorized to act as receiver, domestic, and shall in all cases give such bond as the Court may direct with such sureties as the Court may require.
- 08-69-01 FILING OF CLAIMS IN LIQUIDATION PROCEEDINGS In proceedings to liquidate the assets and business of a corporation the Court may require all creditors of the corporation to file with the Clerk of Court, or with the receiver, in such form as the Court may prescribe, proof under oath of their respective claims. If the Court requires the filing of claims it shall fix a date, which shall be not less than four (4) months from the date of the order, as the last day for the filing of claims; and shall prescribe the notice that shall be given to creditors and claimants of the date so fixed. Prior to the date so fixed. the Court may extend the time for the filing claims. Creditors and claimants failing to file proofs of claim on or before the date so fixed may be barred, by order of the Court, from participating in the distribution of the assets of the Corporation.
- O8-70-01 DISCONTINUANCE OF LIQUIDATION PROCEEDINGS

 The liquidation of the assets and business of a corporation may be discontinued at any time during the liquidation proceedings when it is established that cause for liquidation no longer exists. In such event the Court shall dismiss the proceeding and direct the receiver to redeliver to the corporation all its remaining property and assets.
- ONE-71-01 DECREE OF INVOLUNTARY DISSOLUTION

 In proceedings to liquidate the assets and business of a corporation, when the costs and expenses of such proceedings and all debts, obligations, and liabilities of the corporation shall have been paid and discharged and all of its remaining property and assets distributed to its shareholders; or in case its property and assets are not sufficient to satisfy and discharge such costs, expenses, debts and obligations, all the property and assets have been applied so far as they will go to their payment, the Court shall enter a decree dissolving the corporation, whereupon the existence of the corporation shall cease.
- O8-72-01 FILING OF DECREE OF DISSOLUTION

 In case the Court shall enter a decree dissolving a corporation it shall be the duty of the Clerk of such Court to cause a certified copy of the decree to be filed with the Tribal Treasurer. No fee shall be charged by the Tribal Treasurer for the filing thereof.

08-73-01 DEPOSIT WITH TRIBAL TREASURER OF AMOUNT DUE CERTAIN SHAREHOLDERS

Upon the voluntary or involuntary dissolution of a corporation, the portion of the assets distributable to a creditor or shareholder who is unknown or cannot be found, or who is under disability such distributive portion, shall be reduced to cash and deposited with the Tribal Treasurer and shall be paid over to such creditor or shareholder or his legal representative upon proof satisfactory to the Tribal Treasurer of his right thereto.

08-74-01 SURVIVAL OF REMEDY AFTER DISSOLUTION

The dissolution of a corporation either (1) by the issuance of a certificate of dissolution by the Tribal Treasurer, or by a decree of the Court when the Court has not liquidate the assets and business of the corporation as provided in this Ordinance, or (3) by expiration of its period of duration, shall not take away or impair any remedy available to or against such corporation, its directors, officers, or shareholders, for any right or claim existing; or any liability incurred, prior to such dissolution action or other proceeding thereof if commenced within two (2) years after the date of such dissolution, any action or proceeding by or against the corporation in its corporate name. The shareholders, directors, and officers shall have the power to take such corporate or other or action as shall be appropriate to protect such remedy, right, or claim. such corporation was dissolved at the expiration of its period of duration, such corporation may amend its articles of incorporation at any time during such period to two (2) years so as to extend its period of duration.

08-75-01 ANNUAL REPORT OF CORPORATIONS

Each corporation shall file, within the time prescribed by this Ordinance, an annual report setting forth:

- 1. The name of the corporation;
- The address of the registered officer of the corporation and the name of its registered agent;
- 3. A brief statement of the character of the business in which the corporation is actually engaged;
- 4. The names and respective addresses of the directors and officers of the corporation;
- 5. A statement of the aggregate number of shares which the corporation has authority to issue and par value of the shares;
- A statement of the aggregate number of issued shares;
- 7. A statement, expressed in dollars, of the amount of stated capital of the corporation, as defined in this Ordinance;

- A statement, expressed in dollars, of the value of all the property owned by the corporation, wherever located, and the value of the property of the corporation located within this Reservation, and a statement, expressed in dollars, of the gross amount of business transacted by the corporation for the twelve (12) months ended on the thirty-first (31st) day of December preceding the date herein provided for the filing of such report and the gross amount thereof transacted by the corporation at or from places of business on this Reservation. If, on the thirty-first (31st) day of December preceding the time herein provided for the filing of such report, the corporation had not been in existence for a period of twelve (12) months, or in the case of a foreign corporation having not been authorized to transact business on this Reservation for a period of twelve (12) months, the statement with respect to business transacted shall be furnished for the period between the date of incorporation or the date of its authorization to transact business on this Reservation, as the case may be, and such thirty-first (31st) day of December. If all the property of the corporation is located in this Reservation and all of its business is transacted at or from places of business on this Reservation, or if the corporation elects to pay the annual franchise tax on the basis of its entire stated capital, then the information required by this subparagraph need not be set forth in such report; and
- Such additional information may be necessary or appropriate in order to enable the Tribal Treasurer to determine and assess the proper amount of franchise taxes payable by such corporation. Such annual report shall be made on forms prescribed and furnished by the Tribal Treasurer, and the information therein contained shall be given as of the date of the execution of the report, except as to the information required by subparagraphs 7., 8., and 9. which shall be given as of close of business on the thirty-first (31st) day of December next preceding the date herein provided for the filing of such report. It shall be executed by the corporation by its president, a vice-president, secretary, an assistant secretary, or treasurer, and verified by the officer executing the report, or if the corporation is in the hands of a receiver or trustee, it shall be executed on behalf of the corporation and certified by such receiver or trustee.

08-76-01 FILING OF ANNUAL REPORT OF CORPORATION

Such annual report of a corporation shall be delivered to the Tribal Treasurer between the first day of January and the first day of March of each year, except that the first annual report of a corporation shall be filed between the first day of January and the first day of March preceding the calendar year in which its certificate of incorporation or its certificate of authority, as the case may be, was issued by the Tribal Treasurer.

 It shall be the duty of the Tribal Treasurer to collect all annual franchise taxes and penalties imposed by, or assessed in accordance with this Ordinance.
- Between the first day of March and the first day of June of 08-82-02 each year, the Tribal Treasurer shall assess against each corporation required to file an annual report in such year, the franchise tax payable by it for the period from July 1 of such year to July 1 of the succeeding year in accordance with the provisions of this Ordinance. DENALTIES IMPOSED UPON OFFICERS AND DIRECTORS Each officer and director of a corporation, who fails or refuses within the time prescribed by this Ordinance, to answer truthfully and fully interrogatories propounded to him by the Tribal Treasurer in accordance with the provisions of this Ordinance, or who signs any articles, statements, report, application, or other document filed with the Tribal Treasurer which is known to such officer or director to be false in any material aspect, shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be fined in any amount not exceeding ________ dollars (\$________).

08-85-01 INTERROGATORIES BY THE TRIBAL TREASURER

The Tribal Treasurer may propound to any corporation, domestic or foreign, subject to the provisions of this Ordinance and to any officer of director thereof, such interrogatories as may be reasonably necessary and proper to enable him to ascertain whether such corporation has complied with all the provisions of this Ordinance applicable to such corporation. Such interrogatories shall be answered within thirty (30) days after the mailing thereof, or within such additional time as shall be fixed by the Tribal Treasurer, and the answers thereto shall be full and complete and shall be made in writing and under oath. If such interrogatories be directed to an individual they shall be answered by him, and if directed to a corporation they shall be answered by the president, vice-president, secretary, or assistant secretary thereof. The Tribal Treasurer need not file any document to which such interrogatories relate until such interrogatories answered as herein provided, and then if the answers disclose that such document is not in conformity with the provisions of this Ordinance.

08-86-01 INFORMATION DISCLOSED BY INTERROGATORIES

Interrogatories propounded by the Tribal Treasurer and the answers thereto shall not be open to public inspection for shall the Tribal Treasurer disclose any facts or information obtained therefrom except insofar as his official duty may require the same to be made public or in the event such interrogatory or the answers thereto are required for evidence in any criminal proceedings or in any other actin by this Tribe.

- 08-86-02 Appeals from all final orders and judgements entered by the Sisseton-Wahpeton Sioux Tribal Court under this Section in review of any ruling of decision of the Tribal Treasurer may be taken as in other civil actions.
- O8-87-01 CERTIFICATES AND CERTIFIED COPIES TO BE RECEIVED IN EVIDENCE

 Allow certificates dissued by the Tribal Treasurer in accordance with the provisions of this Ordinance and all copies of documents filed in his/her office in accordance with the provisions of this Ordinance when certified by him or her, shall be taken and received in all Courts, public offices, and official bodies as prima facie evidence of the fact therein stated. A certificate by the Tribal Treasurer under the Seal of this Tribe, as to the existence or non-existence of the facts relating to corporations shall be taken and received in all courts, public offices and official bodies as prima facie evidence of the existence or non-existence of the facts therein stated.
- O8-88-01 FORMS TO BE FURNISHED BY THE TRIBAL TREASURER
 All reports required by this Ordinance in the office of the
 Tribal Treasurer shall be made on forms which shall be
 prescribed and furnished by the Tribal Treasurer. Forms for
 all other documents to be filed in the office of the Tribal
 Treasurer shall be furnished by the Tribal Treasurer on
 request therefor, but the use thereof, unless otherwise
 specifically prescribed in this Ordinance shall not be

- O8-89-01 GREATER VOTING REQUIREMENTS

 Whenever, with respect to any action to be taken by the shareholders of a corporation require the vote of concurrence of the holders of a greater proportion of the shares, then required by this Ordinance with respect to such action, the provisions of the articles of incorporation shall control.
- 08-90-01 WAIVER OF NOTICE

 Whenever any notice is required to be given to any shareholder or director of a corporation under the provisions of this Ordinance or under the provisions of the articles of incorporation or by-laws of the corporation, a waiver thereof shall be in writing signed by the person or persons entitled to such notice.
- O8-91-01 ACTION BY SHAREHOLDERS WITHOUT A MEETING
 Any action required by this Ordinance to be taken at a meeting of the shareholders of a corporation, or any action which may be taken at a meeting of the shareholders, may be taken without a meeting, if consent in writing, setting forth the action so taken, shall be signed by all of the shareholders entitled to vote with respect to the subject matter thereof.
- 08-91-02 Such consent shall have the same effect as a unanimous vote of shareholders and may be stated as such in any articles or document filed with the Tribal Treasurer under this Ordinance.

SEVERABILITY

If any clause, sentence, paragraph, section, or part of this code shall, for any reason be adjudicated by any Court of competent jurisdiction, to be invalid or unconstitutional, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, or part thereof directly involved in the controversy in which the judgement shall have been rendered.
