## RESOLUTION

June 5<sup>th</sup>, 2012

- WHEREAS, The Stockbridge-Munsee Community, Band of Mohican Indians, is a federally recognized Indian tribe with inherent sovereign powers, and is governed by the Stockbridge-Munsee Tribal Council pursuant to the 1937 Constitution;
- WHEREAS, The Stockbridge-Munsee Community has the authority under its Constitution and its inherent rights as a sovereign nation to adopt and amend Ordinances;
- WHEREAS, Chapter 21, the Fish and Wildlife Ordinance, was adopted in 1978 and has since be amended, including a whole-scale changes that resulted in a repeal and adoption of a whole new ordinance in May 2008, and amendments in 2010; and
- WHEREAS, Additional revisions have been identified to clarify provisions on jurisdiction, protected species, group deer hunting, trapping and enforcement authority, as well as creating a new infracting for blocking road access.

NOW THEREFORE BE IT RESOLVED, the Stockbridge-Munsee Tribal Council hereby adopts the following amendments to Chapter 21, which include the following changes:

- Amending 21.2(A), 21.4, 21.15(B)(2), 21.15.5(A), 21.15.5(B), 21.15.5(C), 21.17(B), 21.19(A), 21.20(V), 21.21(A) and 21.21 (B); and
- Deleting 21.8(A)(1), 21.8(C)(1), 21.15(D), 21.15(E), 21.15.5(D)-(G), 21.17(F)(2)(d), 21.17(G)(1) and 21.21(B)(3)(a)-(b); and
- Creating new 21.2(B), 21.12(C), 21.12(D), 21.15(A)(1)(c), 21.17(A)(1)-(3), 21.20(GG) and 21.21(B)(2)(a)-(b); and
- Renumbering 21.17(F)(2)(e)-(g), 21.17(G)(2)-(4), 21.19 and 21.21; and
- Technical change 21.6(B), 21.8(H), 21.17(C) and 21.21(D)(1).
